## Pop TV's "Big Brother After Dark Watch & Win Challenge" Sweepstakes OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER OR WIN

**SWEEPSTAKES DESCRIPTION:** Pop TV's "Big Brother After Dark Watch & Win" Sweepstakes (the "**Sweepstakes**") begins on Monday, July 9, 2018, at 12:00:00 p.m. Eastern Time ("**ET**") and ends on Saturday, September 1, 2018, at 3:15:00 a.m. ET (the "**Sweepstakes Period**"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Pop Media Networks, LLC, located at 28 W 44<sup>th</sup> Street, Suite 1208, New York, NY 10036 ("**Sponsor**"), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal residents of the 48 contiguous United States, and the District of Columbia, who are 21 years of age or older are eligible to enter. Void where prohibited by law. Sponsor, Kaleidoscope Promotions Interactive, Ltd. Airtimes may vary by location, TV service provider, and/or tier of service. Be sure to adjust for your time zone, and check your local listings. Daily Watch & Win Challenges will include Bingo, Trivia and/or a special hashtag to be shared via Twitter. The information needed to successfully complete each Daily Watch & Win Challenge will be announced on-air during the Big Brother After Dark broadcast on Pop TV. One (1) additional entry can be earned each day by completing each Daily Watch & Win Challenge, regardless of outcome (each, a "Daily Challenge Entry"). Up to three (3) Bonus Entries (each, a "Bonus Entry") will be awarded for correctly completing each portion of the Daily Watch & Win Challenge on the sweepstakes web site by using the information announced onair. A total of fifty-four (54) Daily Challenge Entries and one hundred sixty-two (162) Bonus Entries are available per entrant. Each Daily Watch & Win Challenge must be

completed within 15 minutes of the end of each Big Brother After Dark Broadcast (i.e. by 3:15:00 a.m. ET on each Monday, Tuesday, Friday, Saturday and Sunday; and by 4:15:00 a.m. ET on each Wednesday and Thursday) in order for the entrant to receive a Daily Challenge Entry and any applicable Bonus Entry(ies). Sponsor's computer shall serve as the official time keeping device for this Sweepstakes. Neither Sponsor nor Sweepstakes Administrator will verify receipt of entries. If you select the correct answer for any given question on your first try, you will receive one (1) Bonus Entry, for a total of up to three (3) Bonus Entries per Trivia game.
- <u>SPECIAL HASHTAGS</u>: Complete your daily registration at the sweepstakes site, and you may be presented with a Special Hashtag challenge. Click the Tweet Now button and manually replace "#TodaysHashtag" with each Special Hashtag announced on-air during the Big Brother After Dark broadcast on Pop TV, then click "Tweet" to share the message including the Special Hashtag from your Twitter account. If you Tweet the message from your Twitter account, as entered in the sweepstakes registration form, and the Tweet includes the Special Hashtag challenge nights, three (3) will be announced during each broadcast, for a total of up to three (3) available Bonus Entries per day. **SOCIAL ENTRIES:** At the conclusion of each Daily Watch & Win Challenge, each entrant will have a chance to share a message about the Sweepstakes via either Twitter or Facebook for one (1) additional entry per day (each, a "**Social Entry**"), regardless of method of sharing or the number of messages posted through the entrant's social media account(s). To be eligible for Social Entry(ies), you must have a Twitter or Facebook account and be logged in to it. If you do not currently have a Twitter account, you may create one for free at twitter.com. If you do not currently have a Facebook account, you may create one for free at facebook.com. This Sweepstakes is in no way sponsored,

endorsed or administered by, or associated with either Twitter or Facebook. A Twitter account is also required in order to participate in each Special Hashtag Daily Watch & Win Challenge. In the event that any given Big Brother After Dark broadcast is cancelled or preempted, the Social Entry may be unavailable for that particular day.

**DRAWINGS AND WINNER NOTIFICATION:** One (1) Daily Prize Winner will be chosen at random each day from among all eligible daily entries received the previous night, including Daily Registration Entries, Daily Challenge Entries, Bonus Entries, and Social Entries. One (1) Grand Prize winner will be randomly selected on or about September 4, 2018, from among all eligible entries received throughout the Sweepstakes Period, including Daily Registration Entries, Daily Challenge Entries, Bonus Entries, and Social Entries. Each random drawing will be conducted by Sweepstakes Administrator, using randomization methods selected in its sole discretion. The potential Grand Prize Winner will be notified by telephone and/or e-mail using the contact information given at the time of entry.
